1	<u>BUILDING REGULATIONS APPLICATION NUMBER</u> Write the building regulation application number associated with this application for street naming and numbering in this space. This information will assist us in connecting the street naming and numbering application with the relevant building regulations application.
2	<u>LOCATION OF SITE</u> State the address of the site to which the application relates. If applicable, use the site address we have allocated to the related building regulations application or planning application as this is how we know the site. Please be as helpful as possible in identifying the site to us. Note that a site location and layout plan is to be provided with the application in addition to the location address details.
3	<u>NAME OF DEVELOPER</u> Enter the details of the person or organisation developing the site. Provide as much information as possible so that we are able to make contact effectively. If an organisation is making the application provide a contact name for someone with whom we may communicate directly.
4	<u>ABOUT THE DEVELOPMENT</u> The application is to be submitted with a detailed plan showing the plots, the plot numbers, any new streets and the access pathway to the principal entrance to each property. If the development includes flats or maisonettes please provide floor layout plans for each individual block. Existing streets that lead on or off the development are to be clearly marked. Give details of any planned continuation of new roads on future phases that are known at the time of application. After appropriate consultations have taken place, we will assess the application and assign street names and property numbers or agree house names as appropriate. Consultation with the parish council can take 2 months. If we need to contact the applicant regarding proposals for house names, we will do this once a full scheme has been devised and any plots requiring naming have been identified. Please note the decision of the Council is final.
5	<u>APPLICATION CHARGES</u> Charges for applications are based on the number of plots proposed in bands as shown. For plots from 1-100, the charge is a fixed figure within a particular band as shown on the form. For 101 plots or more there is a base charge of £1545 + £11 per plot over 100. VAT is not chargeable on street naming and numbering applications for new developments. If you are in any doubt as to how much the application charge will be, contact the relevant Building Control Authority on the number shown below. Please note that the application charges do not include the cost of provision or installation of the actual street signs required; this cost will need to be paid for separately by the developer.
6	<u>STATEMENT</u> Print your name, sign and date to confirm that all details are correct and to confirm acceptance of the statement.
