

BABERGH AND MID SUFFOLK JOINT LOCAL PLAN EXAMINATION

Programme of further hearing sessions following the Main Modifications Consultation

Following the consultation on the proposed Main Modifications to the plan, the Inspectors have concluded that further hearing sessions (detailed in the Programme overleaf) would be helpful to them on four specific issues:

- **Issue A – Modification of the Plan from a Full Local Plan to a Part 1 Plan and change to settlement boundaries**
(MMs 1,2,3,4,9,10,11,12,14,15 and 93)
- **Issue B – Intensive Livestock and Poultry Farming Policy**
(MMs 47 and 48)
- **Issue C – Protection of Open Spaces**
(MMs 63,64,65 (part),66 and 67(part))
- **Issue D – Natural England comments on the Main Modifications and the Habitats Regulations Assessment**

Invitations to the hearing sessions will be extended to those who submitted written comments on the relevant main modifications. No further written evidence is invited, nor is likely to be accepted, although agendas setting out the main items for discussion at each hearing session will be circulated in due course.

The Inspectors are satisfied that, on the basis of the submitted written representations on the Main Modifications and all previous written and verbal evidence, they can satisfactorily consider all the other matters related to the plan.
