You will not receive a Completion Certificate under Building Regulations until these documents have been produced and accepted by your Building Control Body. It should also be noted that the Energy Performance Certificate cannot be produced without an official address for the dwelling. Please contact the Officer responsible for Street Naming and Numbering at the Local Authority under which the dwelling falls now to arrange naming/numbering of the dwelling as this process can take up to six weeks to complete.
