

Right to Buy Additional Information and Declaration

THIS FORM IS USED TO CONSIDER YOUR ELIGIBILITY FOR THE RIGHT TO BUY YOUR PROPERTY. IT IS USED IN CONJUNCTION WITH THE RTB1 APPLICATION FORM.

The majority of applications are genuine, however given the value of social housing, both in terms of money and the provision of a home to someone in need, it is important we take steps to prevent fraudulent applications. We must also comply with the Money Laundering Regulations which require us to put certain control measures in place to ensure that the council is not part of a financial transaction that could or might amount to handling the proceeds of crime (money laundering).

As part of our procedure, we ask all applicants to meet with us to check the forms are filled in correctly, check personal I.D, check proof of residency and to make sure funds to purchase are from a legitimate source.

We will carry out comprehensive checks at every stage of your Right to Buy application. The information you provide may be shared and verified with organisations such as credit reference agencies, Council Tax, and Housing Benefit. This is so we can detect and prevent illegal activity, such as fraud and identity theft.

If you apply for the Right to Buy and either give false/misleading information or withhold information you may be prosecuted. The RTB1 application form tells you this. Remember, if we uncover evidence of fraud after you have bought the property you can still be prosecuted.

Once you have filled in your forms please contact a member of the Home Ownership team to arrange a meeting. You will need to bring your forms with you together with proof of ID and residency documentation.

You may wish to keep a copy of the completed forms for yourself.
