In accordance with section 23 of the Planning and Compulsory Purchase Act 2004 as amended and at the request of the inspector (Mrs Gregory) following the examination of the Core Strategy Focused Review, Mid Suffolk District Council has published the list of the main modifications that it proposes to the document.

**Core Strategy Focused Review Proposed Submission Development Plan Document (DPD)**

The Mid Suffolk Core Strategy Focused Review 2012 DPD sets out the changes proposed by the Council to its Core Strategy which was adopted in September 2008. The Core Strategy applies to the whole district of Mid Suffolk, however the changes in the review are focused on Stowmarket to ensure conformity between the Core Strategy and the proposed Stowmarket Area Action Plan.

During the examination of the Core Strategy Focused Review the council proposed main modifications to the document and requested that the inspector consider recommending these modifications prior to adoption. At the inspector's request these proposed main modifications have been published for comments to be gathered before she considers her recommendation.
