# Request for Governance Review to Merge Framsden & Helmingham Parish Councils

# **Background**

Mid Suffolk District Council has invited parishes to consider whether it is the best interests of their local community to make any changes to the current parish council definitions through a Community Governance Review (CGR) prior to the elections in 2027, as another opportunity will not be afforded before local government reorganisation. A CGR enables councils to provide improved community engagement, better local democracy and to improve the efficiency and delivery of local services.

# Reasoning for Request to Merge

The villages of Framsden and Helmingham are intrinsically linked, both villages benefit from being geographical neighbours and share a strong sense of community, with residents of both villages using facilities within the two parishes. For instance, there is one primary school shared between the two villages and a number of properties in Framsden are let to tenants by the Helmingham Hall estate. Helmingham has no village hall, so residents often use the Framsden village hall for events.

Helmingham has few tangible assets - only a speed indicator device, bus shelter, noticeboard and two benches, but does has a healthy bank balance that has accumulated over time with no land or real assets to maintain or invest in. Framsden is currently in the process of arranging a lease from the District Council on the piece of land known as Tollgate Corner, with intention to purchase during the next three years. This will provide a community green space for the use of residents of both Framsden and Helmingham and the finance brought by Helmingham by merging would be very useful in progressing this project.

Helmingham Parish Council has recently been subject to a Section 91 Order when it found itself without any locally elected Councillors, or indeed a Clerk, and therefore unable to operate. Since the Mid Suffolk District Councillors have taken up roles to facilitate the Council, the previous Chair of the Council has returned, but the Helmingham Parish Council does not currently reflect the immediate local community. Two options have been considered, converting to a Parish Meeting, or merging with a neighbouring parish. Merging is the preferred options, with Framsden Parish Council being the preferred neighbour.

At the recent Framsden Parish Council meeting of 11<sup>th</sup> July 2025 representatives from Helmingham Parish Council put forward their case that merging with Framsden would be beneficial to both communities, providing representation for all residents at regular Parish Council meetings. Framsden Parish Councillors agreed that the merge could potentially be of mutual benefit in and agreed to starting the process, which would necessitate public consultation and a referendum taking place in both villages.

# **Proposed Form of Merged Council**

There are currently 14 parish councillor positions across the two councils (7 for Framsden and 7 for Helmingham). There are currently only 6 in office (5 for Framsden, 1 for Helmingham – the current Chair - with 3 District Councillors acting as Parish Councillors for Helmingham to enable the council to function). There have been no contested elections in recent years for either council, with both councils routinely relying on co-option to get close to the number of councillors needed. Fewer councillors would be required under a larger Parish Council.

# **Financial Implications**

Although Helmingham Parish Council have not levied a precept for 2025/2026, they have done so for every previous year. However, this does mean that the the proposal to join with Framsden Parish Council, if agreed, would affect the council tax bills of Helmingham residents, as they will be subject to the same precept as paid by the Framsden parish properties. Framsden Parish Council precept for 2025/2026 is £10,918 which equates to £76.18 per household in a Band D property. However, joining with Helmingham will mean a wider Council Tax base (more properties) which could reduce the overall Council Tax per household in Framsden Parish whilst not increasing by as large a margin in Helmingham Parish. There are no changes proposed to the external boundaries of either parish and both parishes fall within the same county electoral division.
