Terms of Reference Community Governance Review Local Government and Public Involvement in Health Act 2007

Terms of Reference

1. Introduction What is a Community Governance Review?

A Community Governance Review is a review of the whole or part of the council's area to consider one or more of the following:

- creating, merging, altering or abolishing parishes
- the naming of parishes and the style of new parishes
- the electoral arrangements for parishes (the ordinary year of election, council size (the number of councillors to be elected to council), and parish warding); and
- grouping parishes under a common parish council or de-grouping parishes other types of local arrangements, including parish meetings

A Community Governance Review is required must consider:

- the impact of community governance arrangements on community cohesions
- the size, population and boundaries of a local community or parish.

The council is required to ensure that community governance within the area under review will:

- be reflective of the identities and interests of the community in that area and
- be effective and convenient

If the council is satisfied that the recommendation of a Community Governance Review would ensure that community governance within the area under review will reflect the identities and interests of the community in that area, and is effective and convenient, the council makes a Community Governance Order.

2. Why is the Council carrying out this Community Governance Review?

The council is required to keep its area under review – every 10-15 years.

Following a number of requests from Parishes for a Review, it was deemed appropriate to undertake a Review of the whole principal council area, rather than dealing with review requests piecemeal.

A Community Governance Review offers an opportunity to put in place strong, clearly defined boundaries, tied to firm ground features, and remove the many anomalous parish boundaries that may exist.

3. Scope of the Review (Amended on 6th March 2024)

Part one of the Review, which started in March 2022 and concluded 26th January 2023 Mid Suffolk Full Council Meeting, considered and resolved the following issues:

- *In relation to Badwell Ash and Long Thurlow and Fressingfield Parish Council, Thurston and Baylham Parish Meeting*

Part two of the review will consider the following issues which were not resolved during part one of the review:

- The boundary between Stowmarket Town Council and Onehouse Parish Council.
- The boundary Battsford Parish Council and Combs Parish Council.

4. Consultation How the Council proposes to conduct consultations during the Review?

Before making any recommendations or publishing final proposals, the council must consult local government electors for the area under review and any other person or body (including a local authority) which appears to the council to have an interest in the review.

The council will therefore:

- publish a Notice and these Terms of Reference on the council's website and arrange for copies to be available for public inspection
- send a copy of the Notice and these Terms of Reference to all parish clerks
- seek to arrange for the notice to be published on parish council websites and notice boards; and
- send a copy of the Notice and these Terms of Reference to all local Members of Parliament Before making any recommendations, the council will take account of any representations received.

The council will publish its recommendations as soon as practicable and take such steps as it considers sufficient to ensure that persons who may be interested in the Community Governance Review are informed of the recommendations and the reasons behind them.

The council will notify each consultee and any other persons or bodies who have made written representations of the outcome of the Review.

5. Considerations (added at stage two of the review)

Legislation requires that the council must ensure that community governance within the area:

- reflects the identities and interests of the communities in the area; and
- be effective and convenient and takes into account any other arrangements for the purpose of community representation or engagement in the area.

In considering proposals for change, the council will take the following into account:

- a strong, inclusive community and voluntary sector;
- a sense of civic values, responsibility and pride;
- a sense of place – a place with a ‘positive’ feeling for people and local distinctiveness;
- reflective of the identities and interests of the community in that area;

- the impact of community governance arrangements on community cohesion; and
- the size, population and boundaries of a local community or parish.

Electorate forecasts

When considering the electoral arrangements the council must consider any likely future change in the number or distribution of electors within five years from the day the review commences.

The review will use the latest electorate figures available at a parish level together with the estimated delivery of new dwellings within the five-year period taken from the council's most recent Five-Year Housing Land Supply Statement.

This information will be included as part of the draft and final recommendations.

Parish boundaries

The council will consider the effect of new and forecast development activity on existing parish boundaries. Parish boundaries should be easily identifiable and reflect the separation of settlements recognised locally as having their own identity. These boundaries should generally reflect the areas between communities with low populations or physical barriers such as rivers or man-made features such as railways or motorways.

Protected arrangements

The Local Government Boundary Commission for England (LGBCE) has completed electoral reviews in the previous five years and as such some parish arrangements are protected. The Council will consider the protected arrangements and will engage with the LGBCE regarding any request to make changes to parish arrangements which are protected.

6. Reorganisation of Community Governance Orders and commencement

The review will be completed when the council resolves to accept the final recommendations and authorises completion of the Reorganisation of Community Governance Order.

Any Community Governance Order made following a CGR should, for administrative and financial reasons take effect on 1 April following the date on which the Order is made. Electoral arrangements will come into force at the first elections to any new parish council following the making of the Order.

Copies of the Order, supporting maps and documents setting out the reasons for the decisions taken will be placed on deposit at Endeavour House Ipswich and on the council's website. They will be publicised in accordance with the requirements of the 2007 Act. All parishes will be notified of the outcomes of the review.

7. Date of Publication

These terms of reference were revised on 6th March 2024.
