Support provided for this choice:		

We may consider undertaking a Neighbourhood Development Order and/or a Community Right to Build Order; however, any decision regarding these will form part of the outcomes from the neighbourhood planning process, which will involve full community engagement.

The proposal to develop a Neighbourhood Development Plan has been discussed at the Annual Parish Meeting and at several Parish Council meetings. Information has also been shared through the parish newsletter, resulting in strong support from residents, with several offering to assist in the plan's preparation. A working group has already been established to begin the process of developing the Neighbourhood Plan.

Within the village, there has been clear support for the proposal, and no objections have been raised. The Parish Council has also approached adjoining parishes to explore the possibility of preparing a joint plan; however, neighbouring villages have either expressed no wish to produce a plan at this time or have indicated that a wider plan would not be beneficial at this stage.

At the most recent Parish Council meeting, there was unanimous support for Hessett to proceed with the development of a Neighbourhood Plan.
